Festival Latino of Lexington Informational Participant (“Participant”) Agreement

1. The participant will provide their own equipment and set-up to the approval of the Lexington-Fayette Urban County Government's Division of Parks and Recreation.
2. Participant employees must be neat, clean and maintain a good attitude with the public.
3. Participant space must be left in a condition equal to or better than the condition it was found in prior to the set-up.
4. Participant may only place signage on their table area and no other location. Signage must be provided by the participant. All signage must be in both English and Spanish.
5. The Division of Parks and Recreation reserves the right to refuse participation to any participant who does not comply with the terms and conditions of this agreement.
6. Participants will not vend any materials or merchandise during the event. Only informational materials may be dispensed, at no charge, to the public or any consumer during the event.
7. Registration application submittal deadline is September 9.

In consideration of being permitted to take part in the Festival Latino of Lexington, the participant hereby releases, absolves, indemnifies, holds harmless and waives all claims against the Lexington-Fayette Urban County Government (“LFUCG”), the Division of Parks and Recreation, and their employees, for any losses or injuries of any kind whatsoever arising out of the operation of the participant’s booth or business.
